

**Terms and Conditions Year End Sale campaign – Q4 2017 Campaign – unifi Bonanza Campaign (unifi/unifi Biz: Advance, Pro, Lite)**

**2. CAMPAIGN OFFERING**

New subscriber that signs up for unifi ADVANCE /unifi PRO for consumer packages or unifi BIZ ADVANCE / unifi BIZ PRO for business packages during the Campaign Period will enjoy special package price for twenty four (24) months. By the end of the 24<sup>th</sup> month's subscription, the monthly subscription fee will be reverted to the prevailing monthly subscription fee of the subscribed unifi package at that time. TM on the other hand shall reserve no obligation to notify subscriber on the change of the subscription fee and will be reflected in the monthly bill starting from the 25<sup>th</sup> month of subscription.

Further, new subscriber that sign up for unifi BIZ PRO / unifi BIZ ADVANCE will enjoy complimentary free calls of up to RM70 ( Simple Voice Plus Plan 70) / RM50 ( Simple Voice Plus Plan 50) monthly respectively for local and national calls for twenty four (24) months. By the end of the 24<sup>th</sup> month's subscription, the complimentary call plan will then later be charged at RM70 / RM50, should Customer wish to continue to subscribe to the call plan.
